**RE: 2012 Annual Board of Directors Election** 

## **TWHBEA**

The purpose of this letter is to report the results of the annual election. We mailed 3,539 ballots and postage-paid return envelopes. The U.S. Postal Service returned (14) fourteen of our mailings as "undeliverable as addressed" and of these we were able to re-mail (1) one. We received 1,158 of our numbered reply envelopes by return mail representing (32.72%). Ballots not counted due to noncompliance with ballot instructions are listed as abstentions or abstained. In Virginia where they were electing two individuals, if a person only voted for one, then the second non-vote was listed as an abstention.

We listed the number mailed and number returned after each state, i.e., TN 1761/684 = 38.8%.
